| February 17, 2022 | Budget Work Session & Regular Board of Education Meeting High School, Middle School and Elementary School Program Review presentations. Special Education program presentation. Review of the Tax Levy Limit Calculation. |
| March 1, 2022 | Assistant Superintendent will submit information to calculate Tax Levy Limit on the Office of the State Comptroller's website on or before March 1, 2022. |
| March 10, 2022 | Budget Work Session & Regular Board of Education Meeting 8:00 pm Presentation of the Superintendent's Recommended Proposed 2022-23 Budget. |
| March 24, 2022 | Budget Work Session & Regular Board of Education Meeting Assistant Superintendent will supply the Board of Education with updated information on 2022-23 Employee Benefits costs and review the projected 2022-23 BOCES budget. |
| April 1, 2022 | District Clerk publishes first publication of legal notice, time and location of school election, budget heading and budget vote. (Must advertise four times within seven weeks of the vote with first publication 45 - 49 days before the budget vote.) |

Second publication of legal notice, time and location of School Budget hearing & budget vote. |
| April 28, 2022 | Budget Work Session & Regular Board of Education Meeting 8:00 pm Board of Education to vote on the Putnam Northern Westchester BOCES Administrative Budget and Board candidates. Budget Book available to the public in district buildings and on the district website. |
| April 29, 2022 | Third publication of legal notice, time and location of school budget hearing and budget vote. |
| May 3, 2022 | SED required salary disclosure form submitted electronically by the Assistant Superintendent. |
| May 5, 2022 | Public Hearing & Regular Board of Education Meeting 8:00 pm |
| May 9, 2022 | Budget Notice mailed to residents including property tax report card. Budget newsletter available to the public. |
| May 10, 2022 | Fourth publication of legal notice School Budget Hearing and Budget Vote; Extended Evening Voter Registration Day until 8:00 pm; Deadline to mail absentee ballots. |
| May 16, 2022 | Deadline for application for absentee ballots if to be picked up. |
| May 17, 2022 | Budget Vote and Election of BOE candidates 6:00 am - 9:00 pm. Absentee voting ballots due by 5:00 pm. |
