

**NOTICE OF SPECIAL DISTRICT MEETING  
BRIARCLIFF MANOR UNION FREE SCHOOL DISTRICT,  
IN THE COUNTY OF WESTCHESTER, NEW YORK**

NOTICE IS HEREBY GIVEN that pursuant to a resolution of the Board of Education of the Briarcliff Manor Union Free School District, in the County of Westchester, New York (the "District"), adopted on September 24, 2018, a Special District Meeting of the qualified voters of said School District will be held on Thursday, December 13, 2018 from 6:00 o'clock A.M. to 9:00 o'clock P.M. (Prevailing Time) at the Todd Elementary School K-2 Cafeteria, 45 Ingham Road, Briarcliff Manor, New York for the purpose of voting upon the following Bond Proposition:

**RESOLVED:**

(a) That the Board of Education of the Briarcliff Manor Union Free School District (the "District") is hereby authorized to construct alterations and improvements to all District school buildings and sites, substantially as described in a report prepared for the District by KG&D Architects, and to expend therefor an amount not to exceed \$33,950,000; (b) that a tax in the amount of not to exceed \$33,950,000 is hereby voted to finance such cost, such tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; and (c) that in anticipation of said tax, bonds of the District are in the amount of not to exceed \$33,950,000 are hereby authorized to be issued and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable.

The voting will be conducted by ballot on voting machines or paper ballot as provided in the Education Law and the polls will remain open from 6:00 o'clock A.M. to 9:00 o'clock P.M. (Prevailing Time) and as much longer as may be necessary to enable the voters then present to cast their ballots.

PLEASE TAKE FURTHER NOTICE, that pursuant to Section 2014 of the Education Law no person shall be entitled to vote at said Special District Meeting whose name does not appear on the register of the District, or who does not register as herein provided. Any person who has registered and voted at any annual or special meeting or election since January 1, 2014 need not re-register.

NOTICE IS FURTHER GIVEN that the Board of Registration will meet on Thursday, December 6, 2018, between the hours of 3:00 o'clock P.M. and 7:00 o'clock P.M. (Prevailing Time), in the District Office of the Todd Elementary School, 45 Ingham Road, Briarcliff Manor, New York, for the purpose of registering voters for the said Special District Meeting to be held on December 13, 2018. Qualified residents may also register to vote by appearing at the Office of the Clerk of the District, 45 Ingham Road, Briarcliff Manor, New York, on any day between the hours of 8:00 o'clock A.M. and 4:00 o'clock P.M. (Prevailing Time) (except Saturdays, Sundays and holidays) up to and including December 7, 2018. The register of the qualified voters of said District prepared for the Annual District Meeting held on May 15, 2018 shall be used by said Board of Registration as the basis for the preparation of the register for said Special District Meeting to be held on December 13, 2018.

NOTICE IS FURTHER GIVEN that any person, otherwise qualified to vote, who is currently registered with the Westchester County Board of Elections for any general election, pursuant to Section 5-612 of the Election Law, shall be entitled to vote without further registration pursuant to Section 2014 of the Education Law.

NOTICE IS FURTHER GIVEN that the register prepared pursuant to Section 2014 of the Education Law will be filed in the Office of the Clerk of the District; that same will be open for inspection by any qualified voter for the District between the hours of 8:00 o'clock A.M. and 4:00 o'clock P.M. (Prevailing Time) on each of the five days prior to the date set for vote, except Sunday, and on Saturday, December 8, 2018, by prior appointment only.

NOTICE IS FURTHER GIVEN that applications for absentee ballots for the Special District Meeting are available at the District Office or on the District web site ([www.briarcliffschools.org](http://www.briarcliffschools.org)) for qualified voters of the District. If the ballot is to be mailed to the voter, the completed application must be received by the District Clerk no later than December 6, 2018. If the ballot is to be delivered personally to the voter at the office of the District Clerk, the completed application must be received by the District Clerk no later than December 12, 2018, the day before the date set for the Special District Meeting. No absentee voter's ballot shall be canvassed unless it shall have been received in the office of the District Clerk of the Briarcliff Manor Union Free School District not later than 5:00 o'clock P.M. (Prevailing Time) on the day of the Special District Meeting.

A list of all persons to whom absentee ballots have been issued will be available for inspection to qualified voters of the District in the Office of the Clerk during regular office hours, 8:00 o'clock A.M. to 4:00 o'clock P.M. (Prevailing Time), until the day of the Special District Meeting. Any qualified voter may file a written challenge of the qualifications as a voter of any person on such list, stating the reasons for the challenge.

Only qualified voters who are registered to vote will be permitted to vote.
