

THE BOND

A bond proposition of \$2,987,000 for security improvements and repairs. It includes: at BMS/BHS, a full campus generator, driveway entrance repaving, gymnasium roof replacements, and a new surface for the track; at Todd, courtyard drainage and replacement floor tiles as needed. It also allows for the replacement of the public announcement system controls in all three schools.

Dear Residents:

The challenge and opportunity of preparing the budget each year are in finding the right balance between high-quality, innovative educational programs, and safe, secure facilities while remaining within the allowable tax levy limit. Developing a school budget is a thoughtful, year-long process that culminates in an annual community vote. In addition to the Board of Education election, this year the District is asking the community to consider two items — the proposed 2019-2020 budget as well as a \$2.99 million bond proposition to address roof repairs and other important infrastructure needs.

In Briarcliff, our District's vision is to "educate and inspire students to become knowledgeable, skilled and confident young men and women." This is achieved through rigorous professional standards, student engagement, academic opportunities and supports, student social and emotional well-being, and outstanding faculty and staff. Ever mindful of this philosophy, we are pleased to report that the proposed 2019-2020 budget supports Briarcliff's comprehensive educational vision because it:

- Maintains or improves our school programs
- Provides greater student support (ICT) in 9th and 10th grade classrooms
- Reduces class size at the middle school
- Supports the implementation of the Columbia University Writing Program K-5
- Promotes the social and emotional well-being of students
- Increases STEAM integration and Computer Science access and offerings K-12
- Continues the District's commitment to ongoing Professional Development
- Addresses new and existing federal and state mandates
- Complies with the allowable tax levy limit

The 2019-2020 budget attends to high-priority facility, maintenance, and safety and security issues. These include replacement of the District's aging WiFi, classroom display devices and network backup systems. It allows for a Todd full-building generator and a new HS Gym scoreboard. It supports our professional security team, allowing for a continuation of coordinated, multi-agency drilling and training activities, and funds for an automated door lockdown system for Todd.

We hope you have taken time to learn about the \$52,690,000 budget which the Board of Education has adopted this year. It represents a 0.95% budget to budget increase and a tax levy compliant increase of 2.69%.

The Board also authorized a bond proposition in the amount of \$2,987,000 for safety & security improvements and repair projects. Specifically, the bond will allow the district to replace both gymnasium roofs, install a Middle/High School generator and repave the driveway entrance at the Middle/High School campus.

Effective, responsive and inspiring school programs are only possible with the support of parents and the school community. This is why we urge you to get engaged and take the time to exercise your civic responsibility and vote on May 21st!





Budget Questions & Answers

How does the budget affect voting and the taxpayer?

How does the NYS school tax freeze rebate affect residents this year?

What happens if the budget fails?

How does this budget support the work and educational initiatives of the district?

Because the budget is below the tax levy limit, a simple majority vote of 50 percent plus one is required for it to pass. The tax levy increase associated with next year's budget it 2.69%.

A New York State property tax freeze took effect in the 2014-2015 school year. Since the Board of Education adopted a budget in compliance with the state tax levy cap, all primary residences currently eligible for the state STAR exemption will be eligible for the tax freeze again this year. If your income is \$250,000 or less, you may opt to either receive a rebate check or a property tax credit. If your income is \$500,000 or more, you must switch to the STAR credit program to continue receiving your benefit. For more information, go to https://www.tax.ny.gov/star/

Under state law, the Board of Education has three options:

- Propose the same budget to the community for a revote.
- Reduce the budget proposal and present through a revote.
- Adopt a contingency budget that carries a zero percent increase in the tax levy.
 In the event of a second failed vote, as per the tax levy cap law, the district would be required to adopt a budget with a zero percent increase on the 2019-2020 tax levy.

This year's budget builds on our distinguished reputation as a high-achieving district. In addition to being the first in Westchester County with fully implemented 1:1 technology, Briarcliff employs innovative practices that differentiate us from neighboring school districts. This budget preserves and enriches essential academic programs at all levels, and maintains all extra-curricular activities and sports programs. Specifically, it maintains all student programs, includes additional high school course offerings, supports the implementation of the Columbia University Teachers' College Writing Program at Todd, increases STEAM integration and Computer Science access and offerings K-12, promotes the social and emotional well-being of students, continues commitment to ongoing professional development, and maintains the Briarcliff Manor Science Research Program. It is our responsibility to provide students with a strong educational foundation and to engage and inspire them to become active, capable adults. The experiences afforded to all Briarcliff students position them well to gain admission to and succeed at prestigious colleges and universities and to become confident participants in the world around them.

Voter Information

Voting for the 2019-2020 school district budget and two Board of Education seats will take place on Tuesday, May 21, from 6 a.m. to 9 p.m. in the Todd Elementary School K-2 Cafeteria, 45 Ingham Road, Briarcliff Manor, New York.



To vote on May 21, 2019 you must be:

- A United States citizen.
- 18 years of age or older.
- A resident within the district for a period of 30 days immediately prior to the vote.
- A registered voter of the district and/ or a registered voter of Westchester County whose name appears on the list supplied by the Westchester County Board of Elections as having voted in a national, state or county election during the past four calendar years.

Absentee Ballot Information

If you will be out of town or unable to vote in person on May 21, you can apply for an absentee ballot. Applications for absentee ballots are available at the district clerk's office, online on the district's website, www.briarcliffschools.org, or you may call 914-432-8130 to have an application mailed to you. Absentee ballots must be received in the office of the district clerk by 5 p.m. on Tuesday, May 21, 2019.
